As the summer of 2002 arrives and local boating enthusiasts are getting out in force, performing needed repairs and/or annual maintenance, optimism for warmer and dryer weather is abundant at the Port Ludlow Marina. So are rumors of the proposed Marina expansion by Port Ludlow Associates. Although not the gripping stuff that best selling novels are made of, my hopes for this article are to both dispel rumor and enlighten the community as to where the approval process lies to date and what the future holds for the proposed 100-slip Marina expansion.

#### **Marina Expansion Description**

First of all, a brief description of the proposed Marina expansion. The proposed action includes the addition of 100 slips to the current 280-slip facility. Slips will range from 36-feet to 60-feet in length, plus side-ties. Associated electrical and utility improvements and the replacement/enlargement of the existing kayak float are also proposed for the Marina expansion project.

#### **Myriad of Governmental Reviewing Agencies**

In order to fully comprehend the "Marina expansion process", one must first establish the bookends by which the process is currently anchored. Those bookends consist of 1) the 1993 Programmatic Final Environmental Impact Statement (FEIS) prepared for the Port Ludlow Master Planned Resort and the subsequent Master Planned Resort Zoning Code and 2) the desired "goal", being a Certificate of Occupancy for the expanded Marina in the Spring of 2004. What falls between is a tangle of regulation, environmental study and conditions of approval by a myriad of governmental reviewing agencies.

The proposed 100-slip Marina expansion was originally conceptualized and vested in the 1993 FEIS, whereby expansion of the Marina could occur upon preparation and adoption of a "resort specific" environmental impact study known as a Supplemental Environmental Impact Statement (SEIS). In order to begin the SEIS process with the lead agency, being Jefferson County, a series of meetings and studies were implemented. In the winter of 2000, Port Ludlow Associates predecessor, Olympic Property Group (OPG), had a Pre-Application Conference with the Army Corps of Engineers and Jefferson County. They had also submitted a Joint Aquatic Resource Permit Application (JARPA) to the Corps of Engineers and to the Washington Department of Fish and Wildlife. Later that year, OPG submitted a Substantial Shoreline Development Permit to Jefferson County and hosted a site visit by the Washington Department of Fish and Wildlife, the Department of Ecology, the Corps of Engineers, Jefferson County and the Department of Natural Resources.

#### **Enter Port Ludlow Associates**

After taking over development operations from OPG in the late summer of 2001, Port Ludlow Associates resumed the Marina expansion permit process by putting the finishing touches on the conceptualized Marina expansion plan. Jefferson County then issued a Determination of Significance (DS) on September 28, 2001, published the DS in local newspapers and held a Public

## PLVC Continues to Look at Alternative Cross-Canal Transportation

The Jefferson County Hood Canal Bridge Mitigation Committee, of which the Port Ludlow Village Council (PLVC) is a member, continues to plan for alternative means of transportation during the 2006 bridge closure and into the future. The ten million dollars of primarily Federal funds allocated to the closure plans will be used for temporary mitigation with the idea that resulting infrastructure and systems could be enhanced and incorporated into long-term and permanent alternative transportation to and from the Olympic Peninsula.

Jefferson County representatives were expected to present their proposal for bridge closure mitigation, with assumptions, to officials of Clallam County as well as the Peninsula Regional Transportation Policy Organization (PRTPO) in June. The assumptions addressed include traffic patterns and growth, ground transportation services, private ferry services, user fees, support projects, and the Hood Canal Bridge restoration. When the proposal is endorsed by PRTPO, it then advances to the Washington State Department of Transportation for adoption into broader mitigation plans for the bridge closure.

Port Ludlow is a major part of the revised proposal for passenger ferry access to the Kitsap Peninsula during the week and "weekender" (Friday through Sunday) service to Seattle. The Port Ludlow Village Council continues to take comments from the Port Ludlow community on the bridge closure mitigation plans. The last opportunity for residents to be heard will be at the **Thursday**, **July 18**, workshop session at the Bay Club beginning at 9:00 a.m.

John Callahan, Hood Canal Bridge Project Manager, will speak to the community at the **Thursday, August 1**, general meeting of the Village Council.

The Jefferson County Hood Canal Bridge Mitigation Committee is composed of representatives from the Port Townsend Chamber of Commerce, the Jefferson County Economic Development Council, and the PLVC, with consultant participation from the Jefferson County administration, City of Port Townsend, Port of Port Townsend, Jefferson Transit, and the North Olympic Peninsula Tourism organization.

## **Emergency Preparedness Group**

The fact that citizens are able to organize themselves in a manner that enables them to complete a comprehensive "snapshot" of the community's needs is an invaluable tool for emergency response agencies at the local, state and federal levels.

#### **Neighborhood Watch Program**

Classes begin **Monday, July 29, through Monday, August 12**, from 9:00 a.m. to 12:00 noon. There is a \$25 fee for supplies that participants take home. If you're looking for something to do together, The Menzies Project research cruise is a great option. Time flies as you scan the sea floor with an underwater camera or draw plankton up from Port Townsend Bay to identify what you found. Together with the on-board naturalist, you'll look for seals to count in Kilisut Harbor, measure a crab, track the currents running underneath you and then view the data you collected on the web site the next day. It's a three-hour cruise you won't want to miss!

Budget cuts hurting your pocket book? Look at these ways to save money.

#### Saving Money on Car Insurance, Part I

Received a speeding ticket lately? Or a ticket for negligent driving? One way that may save you money on your car insurance is to keep your driver's license history as clean as possible. If you have received a citation, you may be eligible to keep it off your driver's license history by taking an approved traffic safety course and not getting another citation for a year.

After you receive the citation, don't just pay the ticket—ask for a mitigation hearing and request a ticket deferment. Traffic Safety Schools are offered in Jefferson and Clallam Counties for a nominal fee of \$35. The six-hour classes are taught on Saturdays in Chimacum and Port Angeles.

#### Saving Money on Car Insurance, Part II

Did you know that in order to sell car insurance in the state of Washington companies are mandated to give a discount to drivers 55 years or older after they complete an approved eight-hour traffic safety course? Several groups offer these courses—

AARP, AAA and the National Safety Council to mention a few. The cost of the class ranges from \$10 to \$25. The amount of the discount depends on your insurance company, but most offer five to ten percent discounts for two to three years. Repeating the class will continue the discount. Some insurance companies even offer the discount to drivers under the age of 55! Call your agent to find out the savings available from your insurance company.

#### Saving Money on Car Insurance, Part III

Drive friendly...drive safely. Wear your seat belt; buckle your child; share the road. And don't drink and drive and don't ride with someone who has been drinking.

## Why Won't the Petunias Grow?

Last year we bought some petunias at a local grocery store. After they had been in the ground for a month there was no sign of new growth, and the pizzery blooms would not open. We took one of the plants into our local nursery and after one look at it they said, "The grower must have had a heavy hand with the growth retardant." All this time I thought growers wanted plants to grow. Yes, they want the plants to grow, but not too large. If they can grow shorter plants and get an extra shelf of plants in their greenhouse the profits are obvious. Also shorter plants transport with less damage, and plants that can be held in suspended growth for a few weeks, allow the retail nursery more time to move them.

Gibberellins are plant hormones responsible for stem elongation, among other things, and are widely used by growers to control the height of plants. Though new to me, gibberellins were first observed in Japan in 1898 in a fungal disease of rice, which would cause the rice to grow rapidly then fall over and rot. In 1939 gibberellic acid was isolated from fungus grown in a petri dish. Today we know this hormone can affect plants; it can change the light and temperature requirements for blooming. It can promote rapid germination of seeds. Levels increase naturally in seeds just before germination, so the early addition of gibberellins can cause rapid germination of seeds. At normal concentrations it seems to promote growth, but at elevated concentrations it inhibits root growth, elongation of stems and blooming.

Since there are no requirements for any grower to report what he does to a plant before he sells it to the nursery, all the customer can do is purchase from a reliable nursery that will stand behind their plants, and replace plants that won't grow because the grower "had a heavy hand with the growth retardant hormone."

My thanks to Bob Lambe for being a resource in my gibberellins research.

## Monthly Meeting News

The Port Ludlow Village Council (PLVC) met on Thursday, June 6. Marie Lytal joined the Council as the representative of the Ludlow Maintenance Commission. The over-two-hour meeting encompassed fairly standard updates from County, developer and committee representatives. In addition there was a lively discussion of the terms agreed to in order to use Port Ludlow Associates' (PLA's) land for this year's Port Ludlow 2002 Festival, which concluded with the possibility that both non-voting commercial representative positions on the Council will be eliminated.

#### **Jefferson County Reports**

Commissioner Dwayne Wilcox declared busy times ahead for the Planning Commission, which faces 23 filings for amendments to the comprehensive plan, among them the Urban Growth Area (UGA) designation for the Tri-Area (Hadlock/Irondale/Chimacum), as well as matters relating to the Shine quarry proposal.

County Commissioner Glen Huntingford extended his congratulations to the PLVC Trails Committee for both the practical benefits and the favorable publicity its work has brought the community. He said the Commissioners support an UGA designation for the Tri-Area in order to best address expansion issues such as storm water handling. Huntingford believes growth in that location is inevitable, and the citizenry should shape the changes by sharing opinions and ideas on boundaries, tax structures, appearance, etc.

He continued saying budget shortfalls are likely to be met this year through cuts in training, out-of-state travel, a hiring freeze and 4 percent salary reductions to be met by each department. The next budget cycle may require cuts in entire programs. Despite concerns from the Port Townsend City Council, the Commissioners are moving to expand the boundaries for commercial development in the Glen Cove area. They will also seek revisions in the Uniform Development Code for light industry to clarify bulk and dimension parameters.

In response to an audience question, Huntingford said there has been little formal activity by Fred Hill Materials

The monthly workshop session will be held **Thursday, July 18**, 9:00 a.m. at the Bay Club. This is the community's final opportunity to be heard regarding transportation alternatives for the period of the Hood Canal Bridge closure in early summer, 2006.

Speakers at the August general meeting of the Village Council are expected to be John Callahan, Hood Canal Bridge Project Manager and Dan Baskins, Plant Manager for Fred Hill Materials.

for him to comment upon. (The company has applied for a comp plan amendment for a mineral overlay on property currently zoned as forestland.) However, the possibilities of expanded mining and a miles-long conveyor belt raise a lot of questions/issues for the County: employment created, revenue impacts, transportation effects, environmental reviews and the time required for County staff to administer a permitting process.

#### **Port Ludlow Associates**

Resort General Manager Michael Padden announced the membership program will kick off on June 15. Renovation of the Golf Clubhouse is slated to begin late in 2002, followed by about two months of demolition and preparation and nine months of construction. The extent of the renovation is variable: the baseline plan will be enhanced depending upon the level of member enrollment. Marina expansion may start after Labor Day, 2003.

#### **Committee Reports**

Marge and Tom Carter of the Trails Committee said the group is optimistic it will achieve its \$12,000 goal for trail maintenance improvements through equal contributions from PLA and the South Bay Community Association, Ludlow Maintenance Commission and the PLVC. The 4.3 miles of Timberton Loop Trail have already been mowed and weed-whacked. Connie Wilkinson said volunteers are needed to monitor the recycling bins for overflow or violations. If you can swing by the Village Center daily for one week this summer, call her at 437-9450. The Tax Committee is contacting the Port of Port Townsend, and hopes to have a Port representative at the August PLVC meeting.

Howard Morse of the Emergency Preparedness Committee has been appointed to Governor Locke's Steering Committee for Emergency Medical Services. Bob Force announced that preparations are underway for the eighth edition of the Port Ludlow Residential and Business Directory. Sales of ads and directories are an important source of PLVC revenue, totaling about \$4,000 annually. Don Cooper reported that vendors are coming to the Friday Market, but in early June the locals were not. He urged residents to visit and buy, or else the market may falter.

#### **Port Ludlow Festival 2002**

Cooper outlined plans for this September's festival, which will feature arts vendors, food booths, a variety of music, formation fly-overs, a golf tournament and a hike of the Timberton Loop Trail. This year's event is being publicized widely, and an increased attendance is expected.

Bert Loomis, the non-voting PLVC member representing local commercial interests, asked President Sally Smith "why (local real estate) businesses were being excluded from a community event sponsored and supported by the PLVC." It was explained that since PLA is in the real estate business itself, as a condition of using PLA property at the Marina President Greg McCarry restricted space rental to non-real estate firms. McCarry said the constraint could be revisited for 2003, and offered to discuss the matter with Windermere partner Kevin Miller, who was in

attendance and reiterated his firm's community support. Loomis insisted it was an issue of fairness, and wanted to know why the condition was accepted, and not discussed with the full Council. Council member Bill Schoenemann said, "Our agents have made the decision...our commitments are binding" and also proposed reconsidering matters for next year. Council member Bob Herbst stated he did not agree with the decision McCarry had made, but the matter was settled for now.

Loomis then said, "I can no longer support the actions of the Council or its leader—this will be my last meeting." McCarry observed that PLA shouldn't participate if other, non-voting commercial interests are not represented, and said he would also step down. President Smith made a motion to accept both resignations. Discussion ensued; several Council members felt actions were being taken too hastily. Some said that Loomis' contributions were valued, and that if he chose to leave another commercial representative could be selected. McCarry repeated that his concern was that PLA not be the sole commercial representative on the board. The motion to accept the resignations failed.

#### **Other News**

A new superintendent has been named for Glacier Northwest Mats Mats Quarry. Jim Tweedy thanked his predecessor, Dean McDonald, and stated his intention to "continue to run (the operation) to the highest standards" and to maintain McDonald's open door policy. The quarry has had over 2,700 days without any lost-time accidents. Truck trips through Port Ludlow have averaged about two and a half per day through May of 2002.

Council minutes are posted at both Clubs. See highlighted box for the agenda, date and location of the next meeting. Note that the July Council meeting will be on the second Thursday and not on the Fourth of July.

## Representation of Commercial Property Owners

When the Port Ludlow Village Council was conceived to represent all property owners in the Master Planned Resort (MPR), the founders felt it was appropriate to have two appointed non-voting Board positions that would represent the commercial property owners. Greg McCarry represents Port Ludlow Associates (originally Olympic Property Group) and Bert Loomis of Loomis Properties represents the other Port Ludlow business

interests. The appointments were made to balance commercial representation on the Council. There are less than a half dozen commercial property owners in the MPR.

At the June 6 Port Ludlow Village Council meeting following a heated exchange, (see Kate Madson's coverage on page 8), we reported Bert Loomis said, "...this will be my last meeting," and that Greg McCarry said he would also step down. McCarry says, "My position is that another commercial representative be appointed or, alternatively, I should step off the Council. PLA is willing to continue to provide updates to the PLVC as requested." A motion to accept these resignations eventually failed. At press time, neither Loomis nor McCarry had submitted written resignations.

The issue of non-voting commercial representatives was slated to be a topic at the PLVC's Workshop later in June. It is likely this issue will be placed on the ballot to be voted on by the entire Village Council membership in September (see related article on page 9). It should be noted that both Loomis and McCarry are both residential homeowners; if these non-voting positions are eliminated, they can both still attend meetings, run for elected positions and vote in the annual election.

### Meet the NRC Mascot

Janet Hanz, an artist/cartoonist, is a member of the PLVC Natural Resources Committee (NRC). As the Committee discussed trails and dogs and the occasional lack of owner responsibility to pick up after their pets, she followed up by drawing a cartoon. It is a "message" to all dog owners in the Village—and will appear in future issues of the Voice to serve as a friendly reminder.

- Visit the site daily
- Call Skookum at 385-7678 when the bins are full
- Call Molly Pearson at 379-4458 with information on illegal dumpers
- Clean up items outside the dumpsters

Stepping up to help would be doing the community a great favor. The Skookum phone number is posted on the bins. They should be called anytime the bins need to be emptied. If you see someone illegally dumping, get a license plate number and call Molly Pearson with that information.

At the Port Ludlow site we recycle:

- Newspapers
- Mixed Paper (Magazines, Junk Mail, Egg Cartons, Lightweight Boxes, Brown Paper Bags)
- Corrugated Cardboard (Broken Down and Flattened)
- White Glass
- Brown Glass
- Mixed Plastic (#1 Drinking Containers Only and #2 Translucent Milk Jugs)
- Metal (Aluminum and Tin)

The Poulsbo Recycle Center should be our model. They take all kinds of glass, so if you really want to help the environment and cut down on Jefferson County's hauling charges, take your green glass there. You can visit that site Tuesday through Saturday from 8:00 a.m. to 3 p.m. It is just off State Road 305 to the north—an extension of Viking Way.

Please call me at 437-9450 if you are willing to volunteer to cover a week this summer. If you don't feel you can commit to a week, please do all you can to keep the recycle area clean and neat. ## What Are You Doing? Why?

When I lived in the California suburbs, the little girl next door often came over to talk to me when I was working in the yard. I always knew what was coming. She had two questions, "What are you doing?" and "Why?" Seems to me that these are pretty good questions to ask about a lot of things I am doing or thinking about doing. To answer her properly required some thought

and reflection—even if I was only spreading snail pellets around the flowers. If Christina had only been around at the opportune moment with these two questions, things might have been different.

For example, when I fell off a ladder the end result was a trip to the hospital. If Christina had seen me up there and asked, "What are you doing?" "I'm painting." "Why?" "Because I don't want to hire someone and I've done it before—when I was thirty years younger—and a man needs to take care of his house…blah…blah…blah." Maybe I would have kept on painting. Or, maybe, I would have seen the stupidity of what I was doing and come down off the ladder and had milk and cookies with Christina.

Now that I am in a Port Ludlow garden, I could still use Christina's questioning. We haven't seen many deer around our house in recent weeks, so, for Mother's Day I decided to buy my wife a rose bush. I planted it in a sunny spot and started checking on various potions to discourage deer. But, too late! The next morning the bush was half eaten. There must be a thriving underground deer-network that alerts the membership. "Attention. Attention. New bush in the area. Your turn, Henry. Go for it." I mixed up a brew of eggs, garlic and hot sauce and sprayed it on what remained of the plant. For good measure I added chunks of Irish Spring soap on strings which I attached to the pitiful stalks that were left. Now I have a smelly bush that looks like a tiny, emaciated Christmas tree. If Christina had been here...

I love the Burning Bush plant. I have several in my yard. They are vibrant, colorful additions to a garden. But, I just discovered that one of them has died. I can just hear Christina: "What are you doing?" "I'm taking out this bush." "Why?" "It's dead." "Why?" Because I planted it in the lowest part of the yard where it is very wet and the roots are saturated and it couldn't survive. In other words, Christina, I planted it in a dumb place—OK?"

The moral of these stories is to ensure better results by thinking of Christina's questions ahead of time. For Example: "I'm going to the Natural Resources Booth at the Friday Market, because I want to tell people about all the wonderful resources around us and where they can hike, visit, or get information about wildlife, their gardens or the forest." Or "I'm headed to a Trails Committee Meeting, or a Natural Resources project, because I want to work with other volunteers to improve our environment and help the community. It's worthwhile. It's fun. And the results are positive." Christina would like these answers.

So, Christina's questions fit many occasions: natural resources, gardening, handyman jobs, and even some self-examination and priority setting. Maybe there's a book waiting to be written with Christina's questions as the title. In the meantime, though, I'll continue to ponder some of the great philosophical, moral and gardening questions of our time like—"What are you doing?" and "Why?"

### Chamber at Your Service

Dan Youra, founding President and a current Board member of the Port Ludlow Chamber, has been active in the organization for eleven years. He started Olympic Publishing Company in Port Ludlow in 1984.

If someone asks you if Port Ludlow has a Chamber of Commerce, how do you answer? "Yes," "no" or "don't know?" The correct answer is "yes." The Port Ludlow Chamber of Commerce started in 1991 as a small group of 23 local business people with four elected to the Board of Directors. Today, eleven years later, the Chamber boasts 70 businesses with nine board members and an administrative assistant. "Wow!" you might exclaim, "I didn't know that. What does the Chamber do?"

The Chamber's self-appointed goals are to:

- help local business owners obtain benefits such as cheaper health insurance
- educate business people on timely topics that affect local business
- lobby politicians and government agencies
- support economic development by promoting tourism
- meet the commercial needs of residents with quality products and services

Membership meetings are held in the Resort at Ludlow Bay Conference Center or the Harbormaster Restaurant. Guest speakers have been politicians running for office, leaders from Pope Resources, Olympic Resource Management, and Benchmark Hospitality. New business owners and local professionals are invited as guests to "show and tell" what they bring to the community. The Chamber has sponsored fund-raising events such as Port Ludlow Home Tours and Music on the Green at the Resort; co-sponsored Rendezvous on Land, Sea and Air; and, in cooperation with other Chambers, supported 4th of July fireworks on Indian Island.

Some activities are more mundane and not so public. For example, board members have traveled to Olympia to lobby the Department of Transportation to provide better signs on the highways to increase safety for residents and to make our community easier to find for friends and visitors. The Board supports lobbying efforts in the halls of our County Courthouse to secure tax dollars that are earmarked for tourism development.

Have you seen the new Visitor Center on Beaver Valley Road at Highway 104? The cute log cabin that replaces the meager trailer would not be there today if it were not for the efforts of the Chamber of Commerce. The Chamber has worked cooperatively with the Port Hadlock Chamber (Did you know there is one?) during the past decade in establishing the Olympic Peninsula Gateway Visitor Center, which now runs the information center in the log cabin.

Would you like to receive a brochure about the Chamber? In addition to publishing its own brochure and list of members, the Chamber publishes regional brochures to invite visitors to Port Ludlow. Tourists are a major source of revenue for local businesses. To promote tourism the Chamber receives lodging tax funds and cooperates with the Visitor Center, Hadlock's Chamber, the Brinnon/Quilcene Chamber (Do they have one too?), businesses on the west end (near the ocean), the lodging tax advisory committee and County Commissioners. ## The Village Garden

Instead of a young man wearing slouchy jeans, baseball cap backwards and oversized, untied Nikes, my interview with Sebastian Edgerton revealed a neatly dressed 14-year-old teen, articulate and focused on a new venture he and his brother, 15-year old Sheffield, have embarked on. It is the Village Garden located between the Northwest Passage Thrift Store and the Village Baker in Chimacum. Their quarterly newsletter states, "The Village Garden is a community garden, created to bring fresh organic produce to the Food Bank. This project is funded entirely by community sweat and support."

The Edgertons live in Chimacum on a 12-acre "farm" and the brothers thought it would be neat to build a fort up the hill, raise their own food and live there during the summer months. They discovered some difficulties in implementing the idea and, because they do volunteer work for the Jefferson County Food Bank, they were aware that the produce donated was not high quality and they wanted to do something about it.

Nancy Edgerton, their mother, encouraged them to create a vegetable garden that would yield fresh produce grown for the Food Bank. They wrote a letter to the owner of the plot, John Gunning, sharing their idea and asked for use of the property. He agreed and is "lending" them the plot along with furnishing the water. Then they contacted Ned Herbert and the staff of Abundant Life Seed Foundation to discuss seeds! Support has grown

and several individuals and businesses have contributed materials or labor. Two greenhouses have been donated and the brothers along with volunteers have created a series of raised beds, all dug by hand, for planting seeds.

This garden is an ongoing project and Sebastian and Sheffield work there each Tuesday, from 8:30 a.m. to 12:30 p.m. and Thursday, from 2:00 to 5:00 p.m. They, along with their parents, work a half day on the weekend.

If people wanting to help the Food Bank would volunteer some time working in the garden, much more could be accomplished. There is planting (seven flats of squashes were recently planted), mulching, weeding and watering so helping hands are needed. The garden is growing beautifully and they have harvested rhubarb. Radishes and red leaf lettuce are about ready, and a big variety of vegetables is growing for later harvest.

Volunteer labor and financial donations are always welcome. The boys need to re-cover a greenhouse and a local business has agreed to give them a 50 percent discount on a professional wheel hoe if they can raise the other 50 percent. ## Does Your Computer Need a Tune-Up?

Just like your car, if you want your computer to work properly, you have to take care of it. This means it should be tuned up routinely. Tune-ups won't guarantee that you won't have problems, but it will keep them to a minimum.



I recently had my computer tuned up at Ty's Computer Service. He let me watch Randy, the technician assigned to do my tune-up. First he wanted to be sure I had all my data backed up and that I had all of my program disks available to be reloaded. There is a simple procedure that would not have altered the hard drive, but I chose to reload Windows and all of my programs. This meant I had to back up all of my data and be prepared to reload all of the Windows and other program updates that had become available since I first loaded the computer.

Ty and Randy prefer that you copy whatever you want to save to insure you don't lose any important data and will assist you if necessary. Randy then copied the names of all the significant drivers in case they were needed.

We have all encountered a glitch that causes our computer to operate at less than a desirable performance level. One of the most common problems is heat. All computers are equipped with small cooling fans that protect the electronic components. If too much dust gets into your computer, the fan becomes ineffective. All the dust in my computer was blown out and the computer was checked for signs of overheating. If necessary, an additional fan could be installed for a small price. My fan was noisy so I had them put in another. I also upgraded my memory and had a new CD burner installed. All of the cables were then checked to be sure that all connections were good.

Since I decided to have the operating system reloaded, it wasn't necessary for the defrag program or any of the registry cleanup programs available for minor tune-ups to be run. Normally they would have checked the memory, processor speed and defragged and checked the registry. I personally recommend reloading the operating system; it takes some time but will usually clear up all of those little problems that occur with use. You must provide the disks.

## LMC Board Accepts PLVC Trails Proposal

In unprecedented action, the Ludlow Maintenance Commission (LMC) Board of Trustees voted at their June 15 meeting to contribute LMC funds to work done on non-LMC grounds. In response to a proposal by the Port Ludlow Village Council (PLVC) Trails Committee and with the recommendation of the LMC Greenbelt Committee, \$3,000 from LMC greenbelt funds will be made available in the coming year to maintain and upgrade existing trails on property owned by Port Ludlow Associates (PLA) and Pope Resources. Acceptance of the proposal was contingent upon the PLVC Trail Committee's preparation of a plan for trails on LMC property. The plan is to be prepared in cooperation with the LMC Greenbelt Committee and the Port Ludlow Drainage District (PLDD).

Arguments in support of the proposal were that LMC funds should be used to support this all-Port Ludlow effort. Arguments against the proposal were that LMC member assessments are for the purpose of supporting LMC common property and would only be appropriate if the trail maintenance and/or development were on LMC common property. The Trustees bypassed an offer that would have allowed North Bay individuals to fund the PLVC proposal for the first year through an alternative membership drive named "North Bay Friends of Our Trails." No opportunity was given for the LMC membership to hear the proposal, hear a presentation by the PLVC Trails Committee or make public comment prior to the Board's affirmative vote.

In other action, the Trustees approved taking money from Reserves to purchase 130 new chairs, similar to those at the Conference Center. The chairs will run several thousand dollars more than anticipated, but cheaper ones are like the unacceptable chairs now in use. The Beach Club now has a newly installed phone system with a remote that is operable throughout the Beach Club grounds. Summer hours have been extended to 10:00 p.m. with pools closing at 9:30 p.m. A PLA request to allow Inn guests

to use LMC pools for a fee is still in negotiation. Port Ludlow Yacht Club reciprocal guests are admitted for a fee. Interest in the LMC Garage Sale has waned and is in need of restructuring if it is to continue.

A favorable kitchen plan has come out of the "Kitchen Cabinet" and is posted for comment. The final schematic plan for the Beach Club remodel is being completed and an estimator has looked at the building in detail. In July or August, the price and possible methods of financing the project are expected. At that time a public forum will be held.

The Covenants and Regulations Committee (CRC) submitted proposed changes to "Policy and Procedures for Observation and Comment by LMC Members" adopted by the Board in October. The accepted changes now state that non-committee members may attend LMC Committee meetings, shall advise the Chair of intent to attend, submit in writing a topic of concern to be addressed, and address the Committee at the discretion of the Chair. The Committee, led by new CRC Chair Jim Laker, will next consider a system of fines.

In other Committee reports, the Architectural Control Committee (ACC) has extended the hours needed for some approvals. There are occasional drainage issues involved that require time for consultation with the PLDD. The Finance Committee presented and the Board approved a revised Delinquent Assessment Collection Policy that includes steps to facilitate the process. There was an increase in delinquent LMC assessments in 2001, deemed "material" by the auditor. The Greenbelt Committee presented a set of guidelines with the recommendation that the Board and membership study the plan. The guidelines are posted and a public hearing may be held prior to its acceptance.

Four appeals are before the LMC Trustees. At least two of them will be considered at the **Saturday**, **July 13**, meeting.

Unleashed dogs have continued to be a nuisance, and in some cases, a danger, as reported by several residents. Warnings have been issued and more stringent measures may have to be taken if the problem continues.

LMC Board of Trustees meetings will now take place on each second Saturday of the month, the next one on **Saturday, July 13**, at 9:00 a.m.

## South Bay Board Update

A lively South Bay Community Association Board meeting was held on Friday, May 24, with ten homeowners present in addition to the Directors. A financial review by Tony Durham showed we still are in a very favorable position related to the budget, with expenses below and revenue above projections. The budget for the next fiscal year was reviewed and shows an operating surplus. Some of the individual elements were judged to be too conservative and will be revised, increasing the projected surplus. Final proposed budgets will be included in the Annual Meeting package, which will be mailed in June.

Barclay Hampton of the Architectural Review Committee (ARC) reported it is having another meeting with Village ARCs to clarify permitting and other procedures. The ARC is concerned that homeowners are not following permitting procedures when they make changes to architecture and landscaping. Bill Schoenemann stated he would write a letter to homeowners reminding them of their responsibilities to follow the CC&Rs as well as the Design Standards. The ARC was also concerned that PLA was not letting them review site plans for new "standard" homes. This could lead to problems such as a heat pump being located next to a neighbor's bedroom. Schoenemann was designated to write a letter to PLA requesting review access by the ARC. Barclay was also concerned that a change be made to the CC&Rs that would allow Villages to initiate their own Architectural Review Committees as long as they stayed within the Master CC&R and Design Standard guidelines.

The entryway at Spinnaker and Paradise Bay Roads will be completed by the addition of beauty bark. Thank you to all the volunteers who made this project possible—it's looking great!

Four candidates are running for the three Board of Director openings. They include current directors Beverly Rothenborg and Chris Whitehurst and new candidates Eline Lybarger and Bill Taylor. Résumés for these candidates are posted at the Bay Club. There was a discussion of increasing the number of Directors on the SBCA Board, but it was terminated, as there was no clear mandate to proceed.

A fountain of activities is gushing forth from the new Activities Committee. Maureen Poole reported she has a super-active group of volunteers who are planning a day at Emerald Downs on **Saturday, August 24**, a get-together for people interested in bowling and cards on **Saturday, July 20**, and a resident coffee and donut get-together on the **second Thursdays of July, August and September**. The "Meet the Artist" program at the monthly cocktail parties has already started. The Board voted to give the group \$500 in seed money to provide for deposits, etc. The Bay Club will control disbursements and receipts of money for events.

The revised SBCA Committee Guidelines were reviewed and approved.

Mike Morgan presented a list of clubs utilizing the Bay Club with a breakdown of Bay Club versus non-Club members. This list will be discussed at the next meeting.

It was decided to enter foreclosure proceedings against the homeowner who has been delinquent in paying dues for over a year.

The Trails Committee presented a comprehensive plan for the maintenance of trails within the Master Planned Resort (MPR). This document which includes maps, detailed maintenance activities and costs is available for review at the Bay Club. Their plan calls for a maximum expenditure of \$12,000 per year to be provided by donations from the LMC, PLVC, PLA and the SBCA. This amount would be reduced by volunteer efforts. All bills will be submit-

ted for payment to each of the four donor parties. PLA has authorized funds and the SBCA Board voted to budget \$3,000 for trail maintenance in the 2002/2003 budget. Since we currently spend \$600 on trail maintenance, this is a net increase of \$2,400.

Mike Morgan will be the new Trash Bash King, as we did not get a volunteer for that position.

A concern was voiced about the adequacy of the facilities as we grow. It is true that our facility is maxed at certain times, but there are other times when a cannon fired at one end of the building would not hit anyone. We need to know if the new Resort is ever going to become a reality, what facilities would be available for large events, and what costs would be involved. In the meantime it is advisable for the next Board to solicit the development of some expansion plans.

The next SBCA meeting is the Annual Meeting to be held **Wednesday**, **July 24**, **2002**, 3:00 p.m., in the Bay Club Auditorium.

### **Eating Around**

#### Manresa Castle

Anyone who dines out regularly knows that restaurants change over time. With this in mind, we revisited Manresa Castle, a very good restaurant, and were pleased to find it was better than ever. Chef Walter Santschi, who had been so popular in the past, has returned with a number of new dishes and techniques. Chef Santschi had taken a few years off to join the Holland America Cruise Line and in so doing has acquired many new skills.

All of the side dishes and entrées were very reasonably priced and the selection was excellent. I started with the grilled Portabella mushroom filled with a roasted pepper, zucchini, caramelized onion and garlic gratinée with Mozzarella cheese, followed by sautéed veal tenderloin medallions with Marsala wine and Morel mushrooms. Three medallions were placed on top of Swiss spaetzle radiating from the center that contained Morel mushrooms coated with a light serving of the Marsala sauce.

My wife had the king salmon rosette; an ample portion of salmon served over a bed of whipped potatoes with fresh spinach. This dish had an incredible presentation. The salmon was arranged in such a way that it looked like a rose in full bloom with the spinach peeking out from under, resembling the leaves of the plant. A sauce of white wine and shallots was used to complete the artistry, proving that presentation is one of the most important aspects of a fine meal.

Our guests enjoyed another delicious dish which I sampled: Chicken Tenderloins Casmir prepared by sautéing the chicken in a Madras curry sauce and served with Thai jasmine rice and caramelized bananas as well as the traditional condiments.

The wine selection is very good, as is the dessert menu and the service was excellent. Unfortunately smoking is allowed in the cocktail lounge and the room is too small to escape the second-hand smoke. I suggest cocktails in the library instead of the lounge.

## Developer's Report

#### **Development Update**

Olympic Terrace (a.k.a. Woodridge II) received final approval by the Jefferson County Hearing Examiner. An appeal period on the decision has also passed which means the project can move forward to final completion. The 41-lot subdivision features half-acre wooded and view lots. Much of the development is complete. Final tasks include installation of power and phone lines, scheduled for late August, and then road paving. PLA has hired architects to design four new models. We expect the design process to be completed by September. The project will feature three furnished model homes to be constructed in fall 2002. Sales are expected to begin in early 2003.

The State Environmental Policy (SEPA) evaluation for the Wedgewood project has been completed. The next step is for the County to issue a final Administrative Decision for approval of the project. Wedgewood is a three-lot shortplat subdivision located at the intersection of Paradise Bay Road and Ludlow Bay Road. Lots are expected to be available for sale by fall 2002.

#### **Housing Starts**

April was a record month for new home sales at Port Ludlow. Then in May we sold our last completed home in Teal Lake Village. Today there is no finished inventory available for sale. At this time PLA's total home inventory is 19 homes—16 are under construction and 3 are complete. All 3 completed homes have been sold and pending closing. Of the 16 new homes under construction, 4 have also been sold. PLA is on pace to install one foundation each week through July.

PLA is planning a tour for Port Ludlow residents of four new homes. The date of the tour is **Friday**, **July 19**, from 2:00 to 6:00 p.m. Two brand new furnished models will be open at Timberton Heights. The first completed town home at Ludlow Bay Village and a completed view home on Rainier Lane will also be open. Residents will be given a coupon that can be signed off at each of the four home locations. All residents who see all four will have their coupons entered in a drawing for prizes. Mark the date on your calendar and see the new properties.

## Golf Clubhouse Size Dependent on Success of Membership Program

Resort General Manager Michael Padden announced the upcoming rollout of the Port Ludlow Membership Program and its related Golf Clubhouse project at the June meeting of the PLVC. Padden, with the assistance of an outside consultant, Community Club Corporation, will manage the enrollment process. Their team was scheduled to arrive in Port Ludlow on Saturday, June 15, to prepare for the community-wide mailing that will include program details. It should arrive at resident mailboxes in early July. The enrollment team will occupy office space adjacent to the Post Office at the Village Center.

In describing the program, Padden said it was broader than just golf memberships and will include other levels such as Marina and social memberships.

Two alternatives are on the table for the Golf Clubhouse. Greg McCarry said, "The building as conceptualized today is 11,000 square feet on the main floor. The plan posted at the Pro Shop will be built on the expectation that membership enrollment goals are met. In the event they are not, a scaled-down version of the building would be built." He continued, "The full architectural plans cost \$450,000; and, because of the cost, we will measure the success of the Membership Program in September to see which version to build."

### Port Ludlow Paddlers Become Stick-in-the-Muds

The annual excursion of the Port Ludlow Paddlers to La Connor took place in "perfect weather" this year. We thought we had it made. The Blue Heron Hotel in La Conner was "perfect," the meal at the Greek restaurant was "perfect," and the weather was hot with no wind on the day of the paddle—"Perfect."

The launch went well and 15 boats (17 paddlers) were gliding across the mirror-like water looking over at Deception Pass, glad we weren't close enough to have to deal with the currents there. We paddled around Skagit Island and a couple of others, stopped and had lunch at a "perfect" spot on one of them, then headed back to our launch site to load up and go home—a "Perfect" trip. "It just doesn't get any better than this" was said several times—but—it isn't over until the fat lady sings!

As we paddled up to the beach where we had started, we realized we had a problem. The tide had gone way out and we had to get our boats over 50 yards of mud before we could get to solid land. Carefully stepping out of the boat and hanging on to it for support (so I wouldn't fall on my

face and disappear), I sank up to my knees in black muck that sucked shoes right off my and a dozen others' feet—never to be seen again.

People on shore that normally rush to help us as we come in, said "no way, Jose." We were on our own. It took a while but we all finally made it in.

If you see someone who is black from feet to knees, you'll know he or she was on the trip. This stuff doesn't come off easily; you have to wear it off. Scoping Meeting at the Bay Club on October 12, 2001 to receive public comment on the proposed Marina expansion. The public comment period ended on November 2, 2001, and based on that input, Jefferson County approved the SEIS Scoping Outline. With the approved SEIS Scoping Outline in place, Port Ludlow Associates then commenced with an updated Eelgrass Survey, a revised Biological Evaluation and Geotechnical Exploration of the associated marine waters in Ludlow Bay.

With all required reports and documentation compiled, Port Ludlow Associates consultant, Reid Middleton, has now finalized the Port Ludlow Marina Draft Supplemental Environmental Impact Statement (DSEIS). This draft document has been delivered to Jefferson County, the National Marine Fisheries Service, Department of Ecology, Department of Fish and Wildlife and the Department of Natural Resources for review and approval. Copies of this Draft SEIS will be available for public review and comment at the Jefferson County Department of Community Development, the Bay Club, Beach Club, Port Hadlock Branch of the Jefferson County Public Library and on-line at www.co.jefferson.wa.us.

#### **Public Comment and Review**

The Port Ludlow Marina Draft SEIS, once distributed, will be subject to a 30-day comment period. Once the comment period ends, Port Ludlow Associates and their consultant will be required to provide written response to each and every comment received during the comment period. Necessary modifications and/or revisions to the proposed Marina expansion plan will occur at that time. This modified document, with comments and responses included, will eventually become the Draft Final Supplemental Environmental Impact Statement (Draft FSEIS). It is anticipated that the Draft FSEIS will be submitted to Jefferson County no later than August 2002. Once the Draft FSEIS is reviewed and approved by Jefferson County staff, publication of the Final Supplemental Environmental Impact Statement (FSEIS) for the Marina expansion can occur.

The Port Ludlow Marina Expansion FSEIS will be available for public review and will have an associated appeal period. At such time as the parallel document, the Resort Redevelopment FSEIS is complete through the same process as outlined for the Marina expansion, a Substantial Shoreline Development Permit (SSDP) Hearing

can be scheduled. The SSDP Hearing is a public hearing whereby public testimony will be taken and addressed by the County Hearing Examiner. After final adoption of the FSEIS and approval of the SSDP, Port Ludlow Associates will then be able to commence with pile driving and Marina construction. This work is currently scheduled for shortly after Labor Day in 2003. Our hopes are to have a Certificate of Occupancy for the expanded Marina in the spring of 2004.

The Festival is held along the beach, on the pier, and in and around the newly renovated Marine and Natural History Exhibit buildings at Fort Worden State Park. This year's Low Tide Fest will feature a myriad of activities, a few of which include:

- Touch tanks and aquaria of marine creatures in the b building on the pier
- Beach walks on marine life, geology, and plants
- Marine and natural history arts and crafts fair
- Natural history exhibits and presentations in the new exhibit on shore

### President's Page

CableSpeed customers need to be aware that Millennium Digital Media (MDM) is in the process of upgrading their systems and will be switching everyone over to Dynamic IP addressing (DHCP). The bottom line on this is that it will improve their existing systems and will provide greater security to their customers. MDM is now mailing out notifications to groups of their customers at a time informing them that the change will be made in five days from the time of notification. They provide reference to a website—how2speed.com—that gives the details of what the customer needs to do. You have to wait until you are notified to go ahead and make the changes now. It would be prudent to do so at this time. We will have a link on our website to the how2speed.com website if you misplace your MDM mailing or cannot remember the help website address.

The directions are quite straightforward, but if you have any difficulty, feel free to seek help from us. The directions distinguish between a customer who has a router (such as Linksys) or not; and if not, which operating system you use on your computer (Windows 95/98/ME/XP/NT/2000 or Macintosh). If you do not have a router, you must make changes in your operating system's Network Application (in the Control Panel for Windows users). Remove the fixed IP address assigned to you by MDM when you had CableSpeed installed and indicate that an IP address be assigned automatically when you log in; and then re-boot your system.

If you have a router, then you will make **no** changes to the Network Application for your operating system. Instead you will access the Setup screen of your router and 1) remove the fixed IP addresses assigned, 2) specify that the

IP address should be automatically assigned, and 3) reset your router. The *how2speed.com* website provides help for some of the routers in use including the Linksys router recommended by us to many of our users. In the case of the Linksys router, if it is reset any new username/password that you assigned may be lost and you will need to log in with the username/password given in the manual. It would be wise to then reassign a new username/password adding another layer of security to prevent break-ins from outside.






